



## INTEGRATED MANAGEMENT SYSTEM POLICY STATEMENT

- e. IMPLEMENTING GOOD CORPORATE GOVERNANCE (GCG) THAT IS IN ACCORDANCE WITH THE GCG PRINCIPLES TO PREVENT ANY TRANSACTION THAT IS DANGEROUSLY CLOSE TO BRIBERY.

THIS UNDERSTANDING SHALL BE THE BASIS UPON WHICH PT TOWER BERSAMA INFRASTRUCTURE, TBK (TBiG) FULLY COMMITS TO IMPLEMENT AND INTEGRATE QUALITY MANAGEMENT SYSTEM; OCCUPATIONAL HEALTH, SAFETY AND ENVIRONMENT MANAGEMENT SYSTEM; INFORMATION SECURITY MANAGEMENT SYSTEM; AND ANTI-BRIBERY MANAGEMENT SYSTEM WITH SUSTAINABLE, CONSISTENT, SYSTEMIC AND RIGHTEOUS WORK IMPROVEMENT.
